

## Public Notice

Please be advised that the Gloucester County Improvement Authority (GCIA) has submitted an application to Gloucester County to include the use of digested biosolids as an alternative daily cover material in the County's Solid Waste Management Plan. GCIA Landfill (Solid Waste Facility) seeks to receive no more than 100 tons per day of digested biosolids, produced as a result of wastewater treatment at The Gloucester County Utilities Authority (GCUA), for use as alternative daily cover material. GCUA biosolids, classified as ID 12, will be delivered to the Solid Waste Facility (GCIA Landfill), on an active portion of the landfill in close proximity to the working face. The biosolids will be delivered during GCIA's operational hours (7:00 AM to 3:30 PM, Monday through Friday) and will not be stockpiled. Following receipt, the biosolids will be blended with soil or other authorized alternative cover material and the blend will be applied as landfill cover material with traditional landfill operating equipment.

The material will be applied and compacted to a minimum thickness of six (6) inches as a mixture that is blended or interspersed with soil or other authorized alternative cover material. The amount of biosolids to be applied in alternative cover blends will be limited to a maximum of 50% which is one (1) part by volume of biosolids to one (1) part soil or alternative cover material. Under an existing contract between the sister agencies, GCUA will manage the transportation of the biosolids product to the GCIA.

Truck routes will be consistent to those previously utilized by the GCUA when hauling incinerator ash to the GCIA. These are the same routes used in conveying GCIA leachate to the GCUA. Specifically, the trucks will leave the GCUA facility, and head South on Paradise Road/Mantua Grove Road and merge onto I-295 South. The trucks will use exit 16A to merge onto Swedesboro Road following which they will continue onto Paulsboro Rd/Paulsboro Swedesboro Rd. At the end of Paulsboro Road, the vehicles will turn right (west) on Kings Highway, followed by a left turn (South) on Glen Echo Ave/Monroeville Road, subsequently reaching the GCIA facility located at 503 Monroeville Rd, Swedesboro, NJ 08085, Block 9, Lot 1, on the right. Since this route was previously used to transport incinerator ash from GCUA to GCIA and is still used to haul leachate from GCIA to the GCUA, any significant adverse impact to road traffic is not anticipated. as a result of this Amendment.
